

## Daily Summary Thursday, June 18, 2009 Afternoon and Evening Sessions

### Journey of the Saints, 4 p.m.

A worship service recognizing our lay and clergy members and clergy spouses who have passed away, those who are going into retirement, and those beginning Conference relationships. A homily was presented by Staci Current for the memorial portion, and Rebecca Hillman provided an interpretive dance. Victoria Schlintz set the context for presentation of the retirees, and Kristin Marshall brought a message to and for those entering the "endless line of splendor" through commissioning and ordination. Paul Sweet, representing the retirees, passed the mantle of spiritual leadership to Motoe Yamada, representing the newly commissioned and ordained. Bishop Brown then reminded us that all persons are called into Christian ministry by virtue of their baptism. Various stages of the lay journey in ministry were acknowledged by those in attendance.

The amendments were presented in writing (on the website previously and two copies per table) and by members of the Conference Delegation to General Conference. Odette Lockwood- Stewart, Renae Extrum-Fernandez, Ted Virts, and Randall Miller made the presentations. At the conclusion of the presentations, final ballots were distributed by the pages to those qualified to vote. Voting took place until all were done and the balloting was closed. Pages collected the ballots and they were tallied electronically by the Conference Secretary. There were 611 ballots collected, 610 valid ballots.
